PART I. GENERAL EXPECTATIONS

Antioch Elementary School agrees to implement the following statutory requirements:

1. **3. 5. **Antioch Elementary School** will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. 6. **Antioch Elementary School** will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:

7. **Antioch Elementary School** will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

8. **Antioch Elementary School** will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --

10. **10.
